businessman, collector, and patron of the arts and humanities—in all respects the very model of a modern Antiquarian; and has been among the most supportive of members for the acquisition of many rare and highly significant items for the Library; and

Whereas DONALD ORESMAN has provided our venerable institution with signal service as a member of the Building Committee, working determinedly to insure that the edifice housing the Society's precious collections speaks to the dream of our nineteenth-century founder even as it provides the security and protection made possible in the twenty-first century; and

Whereas DONALD ORESMAN has chosen to retire from his labors as Councillor and Vice Chairman, after serving the Society long and ably; now therefore

BE IT RESOLVED that the Officers, Councillors, and Members of the American Antiquarian Society do hereby take grateful note of all of the services, contributions, and kindnesses that DONALD ORESMAN has bestowed upon our beloved Society, heartily thank him for his effective role in their affairs, wish him fulfillment and happiness in all that he chooses to pursue, and upon the records of the Society let this Resolution be inscribed and to DONALD ORESMAN let these sentiments be made known.
